## **Your Comments or Concerns**

I want to express my concern over the environmental and human damage caused by the coalburning power plants of Texas.

In 2019, The Environmental Integrity Project published a report on groundwater contamination

resulting from the disposal of coal ash throughout the United States. They used data supplied by the plants to assess the amount of contamination caused by coal plants disposing of coal ash. Their conclusion: In Texas, 100% of coal plans are leaking toxic coal ash into the surrounding groundwater, land, and nearby waterways. Coal ash contains powerful toxins, including arsenic, lead, mercury, chromium, selenium, and boron—which are known to cause cancer, brain damage, cardiovascular disease and damage to the kidneys, reproductive organs, lungs and nervous systems of humans.\*

#### **Your Proposed Solution**

Now that the TCEQ has assumed responsibility for overseeing implementation of coal ash regulations in in Texas, I ask that the Commission exercise more active and thorough oversight of these regulations, particularly to follow up with those plants that have not engaged in the most rigorous testing possible or have not followed through on assessment monitoring.

I ask that the TCEQ take a courageous lead in protecting Texas residents from toxic pollution of their water and land. I ask that TCEQ follow through on the EIP report conclusions that effective monitoring should include the following:

- Requiring coal plant owners to test background wells that are not affected by coal ash;
- Require regular testing of any residential or municipal drinking water wells within ½ mile of coal ash disposal sites, and also to take seriously the justice aspect of this problem and consider and ameliorate the disproportionate impacts of coal ash disposal on low-income communities and communities of color.\*
