THE FIFTH IN MY NEIGHBORHOOD IS LESS THAN 3 MILES AWAY FROM THE FORTH. NO SAFETY
PROTOCOLS OR CRITERIA HAS BEEN SET.

HELLO. MY NEIGHBORHOOD IS IN DESPERATE NEED OF IMMEDIATE HELP FROM CENTERPOINT
ENERGY PLACING A 300,000 GALLON LIQUID PETROLEUM GAS LESS THAN 400 FEET FROM OUR
HOMES, EXXON AND VALERO GAS STATIONS. THERE IS A CHURCH SITTING LESS THAN 400 FT AS
WELL AS A SOCCER FIELD, PARK AND BIKE TRAIL.

NOW CENTERPOINT ENERGY IS FORCING RESIDENTS AND DEMANDING BY ENIMENT DOMAIN OUR
EASEMENT TO LAY 50 X 50 PIPES UNDER GROUND WHICH WILL TAKE TWO YEARS TO TRANSPORT
LIQUID PETROLEUM GAS.

CENTERPOINT ENERGY DID CONSTRUCTION ILLEGALLY DURING COVID-19 WHEN THE WORLD WAS
AT A STAND STILL. MAJORITY OF THE HOME OWNERS NEVER RECEIVED A LETTER AND THE LETTER

Per a Virtual meeting held on July 24, 2021 at 11:00am with Center Point Energy Representatives, Houston Fire Chief Pena and Houston Fire Dept., Hazardous Material Staff. Also, present was Martha Castex-Tatum Houston City Council Member District K. Only 50 residents were informed of this SITTING BOMB in my URBAN NEIGHBORHOOD!!!

The Railroad Commission of Texas took it upon themselves to solely make this life and death situations of my urban community. This project needs to cease and desist.
