Your Comments About the Staff Report, Including Recommendations Supported or Opposed:

I agree that the Driver Training Programs need reform. However, some of the changes to statue that are recommended could have devastating consequences not only to the industry but to public safety as well. I have been in the driver training industry for 27 years and witnessed the need for some of these statues. Please consider why the statues were initially passed.

- 4.1: I agree the Drug and Alcohol Driving Awareness Program (DADAP) is antiquated and no longer useful. Many of the courts require offenders to take the longer courses regulated through TDLR's Offender Education.
- 4.2 & 4.3: These courses were established because of a demand by judiciaries to have young offenders and safety belt offenders attend courses that were more tailored to their offenses.
- 4.5: It is important that courses are taught by fully trained instructors.

Especially since certificates are being issued and submitted for ticket dismissal. To remove the licensing and regulation of instructors would devalue the course offerings.

- 4:6 The required minimum fee was put into place to ensure integrity in courses. Removing it would give online courses an unfair advantage over brick & mortar courses, who have higher operating costs.
- 4.8: It is important that courses are taught by fully trained instructors.
