I agree with the commission's recommended actions.

I would also be happy to see the resources that the TXSG does have leveraged more efficiently. Without sounding like a nagging 21 year old the average age of a TXSG member is around 45-50 and our technology isn't being used effectively, if at all. (i.e. our records management system is extremely under utilized, and our O365 tools are not used as effectively as they could be). The obvious answer would be training at the local level however I believe it would be better received as a "top-down" directive.
