Eliminating Cosmetology and Barbering Instructor licenses is a serious mistake. This profession requires a high level of knowledge in technical skills, SANITATION, public safety, chemicals and interpersonal skills needed for success in the industry. The required hours for Cosmetology have been reduced, and now more than ever, QUALIFIED instructors are needed to give the prospective stylists the training and nurturing needed to be successful. As much as the mega salon chain owners want you to believe that they can do this, it is impossible to achieve in a harried salon environment.

Just because you can cut hair does not mean you are trained to teach students with different learning styles & learning disabilities. The instructor program and curriculum provides a minimum leave of standard for those who wish to teach in the industry. Understanding lesson plans and how to write them and utilize them. Understanding different teaching approaches, classroom management, various testing methods etc are all essential to the training received in this current license. It would be the equivalent of saying it's fine for a recent high school graduate to begin teaching at the college level immediately with no training.

Opening the door for anyone licensed to also teach and complete a TDLR program in instructing or the equivalent would be a thoughtless mistake on the part of any legislator. The public doesn't want or need less qualified and prepared stylists. Safety first. Knowledge and training. We don't want the next pandemic starting in Texas salons. Today, as never before, there appears to be a movement to diminishing/weaken standards of performance, in this case it appears to be all about a need for or against instructors for barbering and or cosmetology. Could it be we're headed toward deregulation of all oversight bodies, what an alarming thought.

As someone who taught in the Cosmetology teaching industry for more years than I'd like to admit; I'm bothered that eliminating an instructor's license for either barbering and or cosmetology could and probably would create adverse actions for consumers of that commodity for years to come. From my perspective, there is a move to totally deregulate both barber and cosmetology, what a dreadful thought.
