I would recommend that minor clerical issues (such as minor mistakes on

forms) be immediately resolved (in a friendly and helpful manner) by staff over the phone or via email to expedite processing times, i.e., Missing forms, updating site approvals, items left blank, etc The LPC Board and staff serving the board need support by the administration to assist LPC's, LPC- Supervisors and LPC -Interns; those who provide for the mental health welfare of the citizens of this state.
