Issue #3 that targets the Barber and Cosmetology Industry

1. Consolidating the Barber and Cosmetology license-Supported ONLY IF the Cosmetology educational requirements of a high school diploma or GED and 17 years of age be in kept. Having a high school diploma or GED brings validity to our profession and helps keep students in school to complete an education. It also prepares the student to further their education in a community college or university, this would will allow them to expand their training to other avenues of the cosmetology field.

2. Eliminate all Instructor's license-OPPOSED! Proper training is the foundation to our industry. A teacher must first learn to teach. There are important factors that go into learning the skill of training others. Being able to break down a skill or it's theory can be a difficult task if one does not understand the steps and sequencing for the student to be able to apply the skill or theory. Every student learns in different ways. Just because one can do the skill does not mean they can teach the skill. There is more to being an instructor than just "teaching"; classroom management, student learning styles, sanitation and disinfection and state testing are just a few of the issues that a licensed instructor faces everyday in the classroom. Not having a specialist instructor's license and ensuring the instructors know the fundamentals of teaching would crumble our industry. As an Instructor in a High School program we go through many hours of professional development and continuing education in order to bring the best out in our students. Eliminating the instructor license only ensures that future students do not have a well-rounded education, and they will only be taught what their instructor is best at doing, which may not cover the required curriculum needed.

3. Eliminating all wig related license.-Opposed. One should have extensive training in sanitation and disinfection for the health of the clients and the stylists; as well as knowledge of scalp disorder and diseases. Most wigs are made of human hair and can become infected with parasites just as a person's own hair. Wigs and extensions require specialized training in cutting, coloring, chemical services, fitting and cleaning therefore; there should be a test and license for it. We should not lose anything that might cause the one working with a client to lose any sanitation

knowledge.

Any Alternative or New Recommendations on This Agency:

Cosmetology is a huge industry for TDLR that generates a large sum of money.

Let us have our own entity (like the old Texas Cosmetology Commission) or allow us to make a new Cosmetology commission that has people with experience in the beauty industry and a commitment to ensure high-quality cosmetology education and representation to handle day to day operations of Cosmetology.
