Your Comments About the Staff Report, Including Recommendations Supported or Opposed:

Its disturbing to think that Texas legislators would not understand and appreciate the significant ramifications of lifting the regulations imposed upon Puppy Mills considering the significant role Texas has historically played in the overpopulation of puppies throughout this country. Texas had been euthanizing substantially higher numbers of animals before the restrictions were levied upon this abhorrent industry which exists solely for profit and promoted by ignorance. The light has now shone on this deeply dark trade, specifically the horrors of abused and neglected animals who are touched only when pups are removed from nursing mothers.

I have no doubt you have been inundated with details of the lack of health care and defects of inbreeding that results from this practice and the heartache that befalls families who purchased a puppy mill puppy sold at pet stores, flea markets, carnivals, internet, and along country roads.
