As the comments period is open until the end of October, 2020, I am writing you in support of the Sunset Commission staff recommended elimination of the Licensed Breeder Program.

- Having been created on the false premise of licensing 600 kennels(USDA & American Kennel Club did not support these numbers) to make it 'revenue neutral', the program has never achieved more than about 175 licensed kennels, therefore costing the state tax dollars in violation of the bill itself.
- The American Kennel Club, the largest and most successful dog registry in the world, never support this program!
- The Licensed Breeder program needlessly duplicates USDA federal standards for breeding animals for sale and duplicates Texas State animal cruelty Law.

  We already have some of the strictest animal cruelty statutes in the US Just enforce them!
