As a Registered Professional Land Surveyor practicing in the State of Texas, I consider the responsibility that I was given, through passage of the Texas RPLS exam, to be one of professional importance and I am extremely grateful to have earned that responsibility. The rich surveying history of the State of Texas was unknown to me prior to studying for the RPLS exam. Understanding both the Spanish and Mexican land grants, the rules/laws that apply to both of those situations, as well as understanding the Republic of Texas boundary laws, was a time consuming and arduous task, but one I thoroughly enjoyed.

Also, I have worked with some highly intelligent people within this industry that were happy to convey their experiences to my benefit. I state these facts because only through studying of the history and gaining real world experience have I been able to confidently apply my knowledge to, as our oath states, "place the interest of the public above all others..."

I have worked closely with Registered Engineers and have come to understand their thought processes when completing a project.
