Mark,

Could you please provide me with a more detailed and certainly more compelling legal justification, in addition to any relevant regulatory explanation, on how it is possible that the currently long established and first approved online TDLR Parent Taught Driver Education Course 101, has been inexplicably and arbitrarily rendered legally null and void, regarding the approval for five traditionally licensed driver education schools to offer this online course in the public domain, with absolutely no mention or connection in challenging the enabling statutory authority or regulatory legal basis or citation supporting this departmental suddenly determined misclassification phenomenon. Trust me, I fully understand and appreciate the special, yet unlawful and unprofessional reasons and motivations of why the department is making this internal review policy misclassification argument at this time. Although, the departments arguments are contrary to all aspects to the rule of law, while ignoring at the same time, the original 1997 legislative intent and establishment of the current State of Texas property owned and approved by online copyright and trademark protected elements of the TDLR Parent Taught Driver Education Course 101, for reasons yet to be properly identified at this time as legally sound and prudent. Also, the department has made no attempt in preventing of stopping the Region 13 Education Service Center from offering the identically approved online TDLR Parent Taught Driver Education Course 101 to the public at this time.

This is an especially relevant argument, when comparing whether or not the submission of other unrelated, irrelevant or unnecessary elements, such as the addition of login in codes, password pages and the inclusions of security software based on the recently related parental taught course submissions, which may have exceeded certain statutory and regulatory provision of the current laws and regulations, and if that's the case, then how do the these newly submitted elements, automatically become an

enforcement priority for the establishment of misclassification discussions, based on the previously referenced internal course review policy, regarding the enforcement of nonexistent laws and regulations, without the corresponding concurrence and approval of the of the Texas legislature?

It's essential at this time, for the department to please provide me with a credible legal justification for supporting the recent internal course review policy discussion decision. At this point, it would appear the department has apparently based its current unlawful discussion decision, solely on the obvious and pointlessly contrived internal course review policy discussion, and the unsubstantiated legal decision resulting from this discussion in making the determination that the current online TDLR PTDE Course 101, is somehow no longer considered to be an eligible online course? Simply stated, how is that even possible, legally or otherwise? In all due respect, would the department please reconsider its recent decision regarding this matter.

In response to this email, upon an internal course review policy discussion with staff that compared elements of other online DE course offerings, PTDE 101 appeared to be misclassified on the search tool as an "online course". There was no specific rule that pertained to the PTDE course classification on the search tool. Staff, as a policy determination, viewed a PTDE course as an "online course" for classification on the search tool as a course that has such elements that include a login and password page, security software, such as content and personal validation tools, etc.

In examining the issues you raised regarding PTDE 101, staff determined that it was not an "online course" with the policy reconsideration, and will review other courses that are similar in their offerings as PTDE 101 and reclassify accordingly. Thus, PTDE 101, and course of that same or similar makeup, will eventually be found in the search tool under "Full Course-Printed Material/CD-ROM/DVD" to be equitable.

Thank you for your inquiry and I hope this clarifies matters.
