I COMPLETELY support the paying of the 15.2% of fees on full-time rehires after they have sat out a year (should not have to sit out a year to start with as long as the 15.2% fees are paid once the rehire begins, and someone at TRS has some big hooks in the Texas Senate because the Texas House voted in 2019 to do away with the one year required sitting out before rehiring and after the house vote it could not even get a hearing in the Texas Senate).

The \$535 monthly penalty on TRS care if someone rehires is RIDICULOUS and nothing short of robbery and should be stopped immediately and should have never started. Worse case scenario is that retire-rehires would have to go back to using TRS active care as they did when they were active before rehiring once they rehire. That is probably NOT necessary, but makes some sense to require re-hires to go back to TRS active care and not be eligible for enrollment in TRS care while they are rehired.
