I was recently informed by my son's doctor that you are reviewing Barrett and Quackwatch having access to our Texas physician's. It is my sincere hope that you are committed to protecting TEXAS doctors, TEXAS families and TEXAS patients and keeping this guy out of our great state.

I have actually spoke to Barrett. He had reported my son's doctor at the Care Clinic in Austin, TX. The report was filed at the Florida location using his "anonymous" tactic. I asked him why he was so critical. He explained to me about his two son's being diagnosed on the spectrum and felt he had been misled. I also informed Barrett of this as well. My brother was on staff at Cleveland Clinic during my son's time at the Care Clinic and is still a practicing surgeon. He was very aware of what medical practices were going on at the clinic and I consulted with him regularly and shared the comprehensive test results from the medical treatments. Again, Barrett wasn't interested.

As you know, all charges were dropped against the clinic but they achieved their goal of shutting it down and robbing hundreds of children the medical care they were getting and having success. That would include my son.

However, I know of the stressful decisions my son's uncle and other doctors have to make in the medical profession.
